|   | It is the policy of the Board that no student shall be discriminated against, segregated or stigmatized based on his/her homeless status.   |

This includes youth who have run away from home; been<br>abandoned or forced out of home by a parent, guardian or other caretaker; or<br>separated from a parent or guardian for any other reason.  |

Such notice shall be provided in a manner and form understandable to the parents/guardians of homeless children and youths.  |

| 4. Guidelines           | Enrollment/Placement   |
| 42 U.S.C.<br>Sec. 11431 | Best Interest Determination –  |
|                         | In determining the best interest of a child or youth, the district shall:  |
| 42 U.S.C.<br>Sec. 11432 | 1. Presume that keeping the child or youth in the school of origin is in the child's or youth's best interest, except when doing so is contrary to the request of the parent/guardian or unaccompanied youth.  |
| 42 U.S.C.<br>Sec. 11432 | 2. Consider student-centered factors related to impact of mobility on achievement, education, health and safety, giving priority to the request of the parent/guardian or unaccompanied youth.   |
| 42 U.S.C.<br>Sec. 11432 | 3. If, after such consideration, the district determines that it is not in the child's or youth's best interest to attend the school of origin or the school requested by the parent/guardian or unaccompanied youth, the district shall provide the parent/guardian or unaccompanied youth with a written explanation of the reasons for its determination. The explanation shall be in a manner and form understandable to the parent/guardian or unaccompanied youth and shall include information regarding the right to appeal. |

| 42 U.S.C.<br>Sec. 11432  | Parents/Guardians of a homeless student may request enrollment in the school in the attendance area where the student is actually living or other schools.   |

| 42 U.S.C.<br>Sec. 11432                    | The district's liaison shall participate in professional development programs and<br>other technical assistance activities offered by the Coordinator of Pennsylvania's<br>Education for Children and Youth Experiencing Homelessness Program.   |
| 42 U.S.C.<br>Sec. 11432                    | The district's liaison shall arrange professional development programs for school staff, including office staff.   |
| 42 U.S.C.<br>Sec. 11432                    | School personnel providing services to homeless children and youths, including school enrollment staff, shall receive professional development and support to:   |
