| 2. <u>Authority</u> | The Board authorizes the principals under direction of the Superintendent to enforce school regulations prohibiting student dress or grooming practices which:   |                                 |
|                     | <ul> <li>present a hazard to the health or safety of the student<br/>him/herself or to others in the school</li> </ul>   |                                 |
|                     | <ul> <li>materially interfere with school work, create disorder,<br/>or disrupt the educational program</li> </ul>   |                                 |
|                     | - cause excessive wear or damage to school property  |                                 |
|                     | <ul> <li>prevent the student from achieving his/her own educational objectives because of blocked vision of restricted movement</li> </ul>   |                                 |
