Penny Balavage, resident of Zerbe Township, commented on the past expenditures of the District and asked that the Board accept the Arbitrator's decision and allow the District to move forward.

1. Arbitration Case #01-15-0005-2549

Motion to reject the Determination of the Arbitrators in AAA Case #01-15-0005-2549.

He announced the Board would follow the recommendation of the school solicitor, Richard Roberts, to vote against the report due to several violations to the Pennsylvania School Code, specifically negotiating class size and maintaining a specific number of teachers in a contract.
